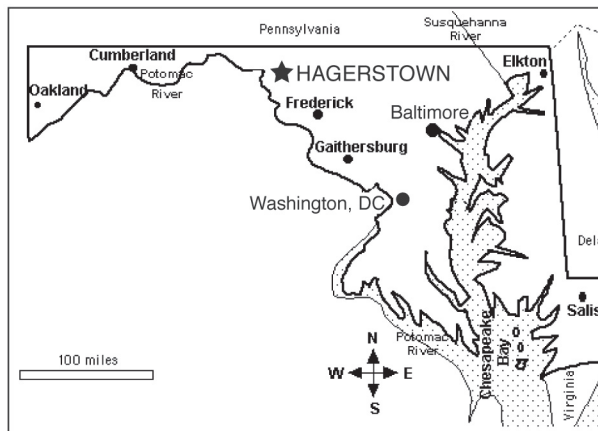
These races run concurrently with the Hagerstown Duathlon and Triathlon and Use a similar run course using the park Path and park road.
